TO BECOME A MEMBER

A person of either sex shall be eligible for membership if he possesses the following qualifications:

1. *Should not have been convicted of a criminal offence involving fraud or dishonesty.*
2. *Is not directly or indirectly carrying out such activities which are detrimental to the objectives of the SACCO.*
3. *Is of good character.*
4. *Is an employee of the society or investments or business affiliated to the Society*
5. *Public service employee*
6. *Employee of any private organization and parastatal organization*
7. *Business owners*
8. *A child of a member*
9. *Is a Nominee of a member*
10. *Is a person of integrity and good character referred by an existing member*

Members shall be admitted into the SACCO subject to confirmation by the vetting committee

TO BECOME A MEMBER

- i. Payment of Membership fees (currently Ugx. 50,000)
- ii. Purchase of Minimum shares of Ugx. 1,000,000 (100 shares at 10,000 per share)
- iii. Must be in position to save at least Ugx. 100,000 per month
- iv. welfare fees 100,000 per annum
- v. Default on saving for 3 months will cause closure of the account and any money refunded at the end of the year along with any dividends and interest.

MEMBER BENEFITS

Member Welfare: Each member must contribute 100,000 annually to assist any member who is ill (admitted in hospital) or who has died or lost a biological parent, child or spouse with UGX. 250,000. The SACCO also contributes UGX 250,000 for any member getting legally married.
